RELEASE AND WAIVER OF LIABILITY AGREEMENT

I, the undersigned Exhibitor/Participant, acknowledge that I have voluntarily applied to participate in the Lassen County Fair Horse Show/

I AM AWARE THAT ANY AND ALL SUCH ACTIVITIES ARE HAZARDOUS AND I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED. I AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE.

As consideration for being permitted by the Lassen County Fair, the County of Lassen and the State of California to participate in these activities and use their facilities, I hereby agree that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives will not make claim against, sue or attach the property of the Lassen County Fair, the employees agents, or contractors for injury or damage resulting from the negligence or acts, however caused, by any director, employee, agent, or contractor of the Lassen County Fair, the County of Lassen or the State of California or any of their affiliated organizations as a result of my participation in the activities described above. I forever release the Lassen County Fair, the County of Lassen and the state of California and any of their directors, employees, agents, or contractors or affiliated organizations from any and all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, next of kin, spouse and legal representatives now have or may hereafter have injury or damage resulting from y participation in the activities described above.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE LASSEN COUNTY FAIR, THE COUNTY OF LASSEN, AND THE STATE OF CALIFORNIA AND THEIR AFFILIATED ORGANIZATIONS AND CONTRACTORS, AND I SIGN IT OF MY OWN FREE WILL.

Upon signature and submittal of entry form, exhibitors/owners and their agents, parents, leaders acknowledge that: a) They understand the State Rules and the Local Fair Rules; b) They agree to abide by them; c) They certify that all information on this entry form is true and correct; d) They agree to comply with the Fair's decision regarding any violation of the rules; e) They acknowledge that the Fair is not responsible for errors of any kind on this entry form and that no refunds will be made except as specified in State Rules; and f) In the care of established unethical treatment of animals, or violation of drug policy rules, exhibitor names will be forwarded to Fairs & Expositions. Exhibitors will be indemnify Fairs & Expositions, the Lassen County Fair, its officers, agents, employees, and Horse Show Management from any and all claims and losses occurring or resulting to their person, animals, firm or cooperation who may be injured as a result of their participation.
